## Code of Ethics Education

The Academy and its credentialing agency, the Commission on Dietetic Registration, believe it is in the best interest of the profession and the public it serves to have a Code of Ethics in place that provides guidance to dietetics practitioners in their professional practice and conduct.

The Code of Ethics Task Force reviewed and revised the 1999 Code of Ethics in March 2009. The Academy Board of Directors, Commission on Dietetic Registration and House of Delegates approved the revised Code in May 2009. The 2009 Code of Ethics was published in the August 2009 Journal of the American Dietetic Association, now Journal of the Academy of Nutrition and Dietetics, (pages 1461-1467). The 2009 Code is in effect as of January 1, 2010 and the 1999 version of the code is no longer valid.

Responding to a recommendation from the Academy of Nutrition and Dietetics Board of Directors, on May 9, 2011, the Commission on Dietetic Registration voted to require that RDs or RDNs and DTRs complete a minimum of 1 CPEU of Continuing Professional in Ethics (Learning Need Code 1050) during each 5-year recertification cycle

This requirement will be effective starting with the 5-year recertification cycle which ends on May 31,2017 and will be phased in over a 5-year period for each recertification cycle. ## **Ethics Education Toolkit**

The Academy of Nutrition and Dietetics and Commission on Dietetic Registration (CDR) joint Ethics Committee has developed this "Facilitators' Guide" to assist dietetics educators and practitioners in providing information to current and future members and credentialed practitioners about the Academy/CDR Code of Ethics for the Profession of Dietetics. This Guide offers an overview of the Academy/CDR Code of Ethics along with guided discussion and is not intended to be an in depth study of professional ethics. Although facilitators are welcome to adapt time frames to their individual schedules, the script, activities and handouts in this Guide have been designed for a one hour and thirty minute presentation. Eleven different handouts are provided for use in a session, including case studies for discussion. 1.5 CPE are offered for an individual attending a session that uses the toolkit; 2.5 CPE are offered for the presenter of this session.

A "For Further Reading List" can be used by educators to direct reading and learning objectives for students in the area of ethics and ethical behaviors as a professional in dietetics. Practitioners can use the list to keep current on ethics and the impact on practice. This list was prepared by the Academy Ethics Committee and will be updated once per year, in August.

## **Members Succeed With Requesting Additional MNT Coverage**

Requesting additional MNT coverage for your patients may sometimes seem very daunting, "but the squeaky wheel gets the grease!" I watched a webinar recently that talked about the success of dietitians requesting additional MNT coverage. One statement that really stuck with me was just that, "the squeaky wheel gets the grease." The presenters of the webinar proceeded to explain how dietitians are often successful with requesting coverage even after being denied the first time. After being denied, the dietitian would send their form and letter again urging the insurance company to reconsider their request and often, it was approved. This statistic honestly kind of shocked me but also encouraged me.



Recently I have had some success requesting additional MNT visits from Medicaid for a child with Prader Willi Syndrome. As it often goes along with this disease, this child is very overweight and it was discussed at an interdisciplinary team meeting through the Child Disability Clinic at MSU in Minot, ND that this patient would benefit from more regular visits with the dietitian. We decided that monthly visits with the dietitian would be our goal. To request monthly visits, I filled out the "Medical Procedure/Device Prior Authorization Request" Form (SFN 511) and wrote a letter to Medicaid using the sample MNT letters posted on the NDAND website. I faxed the form and letter to Medicaid and to my surprise, Medicaid approved monthly visits for this patient. When the family found out, they were very excited!

Kelly Fisher, RD, LRD, CDE has also had success with Blue Cross Blue Shield in receiving coverage for additional MNT visits for her patients with eating disorders. Letters are written justifying the need for additional visits. Case management may request documentation from past visits before approving additional visits and more often than not, Kelly receives approval for the number of visits she requested. Kelly and Kayla are making a difference, one letter at a time and so can you!

We encourage you to be an advocate for your patients and services you offer. There are sample MNT letters posted on the NDAND website under member benefits to help you get started. You will never know if you don't try. If your first request is denied, don't give up. Try again and hope for the best! ## **Bylaws Update**

The North Dakota Academy of Nutrition and Dietetics (NDAND) Board of Directors has recommended changes to the bylaws related to board structure. There are three primary areas of change being proposed:

- 1. Voting privileges will be added to a number of board positions that have not previously been voting members of the board.
- 2. All voting board members will be elected by the membership, rather than appointed by the president or president elect.
- 3. Bylaws will be able to be amended by the elected board, rather than requiring a vote of the entire membership.

The primary rationale behind these recommendations is that many board members who attend board meetings do not currently have the right to vote. With these changes, all elected board members would be allowed to vote and have more of a "voice" in making board decisions. NDAND members still continue to have a voice by deciding who will be elected to the board. These proposed revisions have been reviewed and approved by the Academy.
